#### Call to Order

Board Chair Linda Parsons called the meeting to order, roll was called, and a guorum was declared.

# Sale to Chenal Heights Retirement Center, Inc., LLC

The Board discussed the offer of Chenal Heights Retirement Center, Inc., LLC, to purchase four acres for an assisted living facility near the site authorized for sale at the June 15 meeting of the Board for a nursing home in Chenal Valley. The purchase price for the four acres would be \$812,812.50 in cash, subject to approval from the Arkansas Health Permit Agency to locate on the property and approval from the State of Arkansas Office of Long Term Care Inspector for the site. Charles Dyer moved

adoption of **Resolution No. 2004-25** (attached) approving the sale, Hazel Coleman seconded, and the Board unanimously approved the motion.

3. Sale of Jonesboro Property

The Board reviewed the proposal of Mark Fowler to purchase approximately 35 acres of property owned by ATRS in Jonesboro, Arkansas, at a price of \$19,500.00 an acre, the exact amount of land to be determined by a survey. ATRS will continue to own adjacent property, and Mr. Malone stated that the staff believes the sale will enhance future development of the remaining ATRS property. Monty Betts moved adoption of *Resolution No. 2004-26* (attached) approving the sale, Charles Dyer seconded, and the Board unanimously approved the motion.
