- I. Call to Order/Roll Call. Chair, Dr. Abernathy, called the Board of Trustees meeting to order at 10:25 a.m. Roll call was taken and the member absent was Dr. Diana Julian.
- II. Adoption of Agenda.
  - Ms. Coleman moved for adoption of the amended Agenda. Ms. Riddle seconded the motion and the Board unanimously approved the motion.
- III. **Executive Summary.** The Executive Summary was provided for reference with no questions or expansions on the written summary.

## IV. Investment Committee Report.

A. Consideration of Proposed Purchase of 10,000 Plus Contiguous Acres of Arkansas Timberland (Arkansas Related Investment) (Resolution 2009-24).

Mr. Hopkins gave a brief summary of the proposed purchase of 10,000 plus contiguous acres of Arkansas Timberland. The tract is currently well developed and contains very fertile, high quality land. Projections estimate a 9% return over the next ten years. Mr. Hopkins requested of the Board authorization for an initial bid of \$11,315,000, with the cap set at \$13,710,000. The bidding closes at 3:00 p.m. on Thursday, August 27, 2009.

Mr. Lester *moved* for the *adoption* of Resolution 2009-24 to authorize ATRS staff to bid on the 10,000 plus contiguous acres of Arkansas Timberland, and otherwise acquire, if its bid is accepted, an amount up to \$13,715,000. Ms. Leming *seconded* the *motion*, and the Board *unanimously adopted the Resolution*.

- B. **Portfolio Performance Update for July 2009, Preliminary.** Mr. Hopkins gave a brief overview of what Mr. Kelly had covered in the Investment Committee. The total fund performed at 5.6% for the month, 0.5% above the benchmark. Overall, the total fund value is \$9.2 billion.
